

“Ultimate Fan Sweepstakes”
OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES DATES: The “Ultimate Fan Sweepstakes” (the “Sweepstakes”) starts at 12:00am PT on October 30, 2023 and ends at 11:59:59pm PT on January 11, 2024, subject to two (2) entry periods, with one (1) drawing occurring per entry period as set forth in the “ENTRY PERIODS” section below.

ELIGIBILITY: To enter the Sweepstakes, you must be a lawful permanent resident of the fifty (50) United States or the District of Columbia and at least the age of majority in your state of residence (nineteen (19) in Alabama, Nebraska, twenty-one (21) in Mississippi, and eighteen (18) in all other states) at the time of entry (the “Entrant”). ALL NON-WINNING ELIGIBLE ENTRIES RECEIVED DURING PREVIOUS ENTRY PERIOD(S) WILL NOT CARRY OVER TO SUBSEQUENT ENTRY PERIOD DRAWING.

HOW TO ENTER: There are two (2) ways to receive entries into the Sweepstakes.

- 1. QuickPay Direct Deposit:** Entrants must have a professional football player card design and are enrolled in QuickPay Direct Deposit will receive one (1) entry when Entrant makes one (1) qualifying direct deposit of at least \$100 or more using either a paycheck or government benefits check deposited to Entrant’s CARD Premium Bank

Account by Pathward (the "Account") during an Entry Period. PLEASE NOTE: In order to qualify as a qualified entry, each direct deposit must be posted to the Account by the postmark or Direct Deposit posting date(s) indicated in the Entry Period Chart to be eligible for the applicable Entry Period drawing. Direct deposits posted to the Account after 11:59 PM PT on January 11, 2024, will not be considered an entry.

2. **Mail-in Method of Entry: To receive entries into the Sweepstakes without having or using an Account to make a direct deposit**, on a plain 3" x 5" card, legibly print or type your name, age, complete address, city, state, zip code, home phone number (including area code), and email address (if any). Mail-in entries must be postmarked and received by the dates indicated in the Entry Period Chart to be eligible for the applicable Entry Period drawing. No mechanically or programmatically reproduced entries are permitted. One (1) entry per envelope.

Limit of 1 entry per Entrant for each Entry Period, regardless of method of entry. There is a limit of one (1) Grand Prize per Entrant. Entrant may only use one (1) Account and one (1) email address to participate in this Sweepstakes. RANDOM DRAWINGS/ODDS OF WINNING:

Entry Period drawings: On or about the drawing dates outlined in the Entry Period Chart, one (1) Grand Prize Winner will be selected in a random drawing for each Entry Period conducted under the supervision of the Sweepstakes Administrator, an independent judging organization, whose decisions are based on their sole discretion and interpretation of these Official Rules and are final and binding in all respects. All non-winning eligible entries from previous Entry Period drawings will not carry over to subsequent Entry Period drawings. Odds of winning depend upon the total number of entries received during the respective Entry Period.

PRIZES:

Grand Prizes: Each Grand Prize Winner will win one (1) NFL signed football from one of the six professional football players (each a "Grand Prize"). Total approximate retail value ("ARV") of each Grand Prize is \$1,100.

PRIZE RESTRICTIONS: There is a limit of one (1) Grand Prize per Entrant/household for the entire Sweepstakes. No prize substitution, except at Sponsor's sole discretion or as otherwise provided herein. Grand Prizes are not transferable prior to award. All federal, state, and local taxes on any prize are the sole responsibility of the Grand Prize Winner and are not transferable. The Grand Prize Winner is solely responsible for all other expenses not specified herein, including but not limited to applicable taxes and Account fees.

Sponsor reserves the right to exclude from the Sweepstakes any potential Grand Prize Winner who is suspected of theft, fraud, or any criminal activity related to Sponsor or its affiliates. Entries associated with fraudulent Accounts or other unauthorized use of Accounts and entries

associated with any similar fraudulent or inappropriate activities relating to any such Accounts will be void and all such Entrants may be disqualified.

NOTIFICATION/PRIZE CLAIMS: Potential Grand Prize Winner will be contacted by telephone or email within five (5) business days of the drawing date (the "Notification"). If the Grand Prize Winner cannot be contacted or the Grand Prize Winner does not respond to the Notification within the date and time indicated within such Notification, then that Grand Prize Winner may be disqualified and an alternate Grand Prize Winner may be selected through a random drawing from among all remaining eligible non-winning entries.

Except where prohibited, the potential Grand Prize Winner must sign and return, within five (5) days of receipt, an Affidavit of Eligibility/Liability/Publicity Release and an IRS W-9 Form (the "Paperwork") in order to claim the Grand Prize.
